## VILLAGE & TOWNSHIP UPDATES

**Mantua Township:** An open house for the annex is to be held, bidding to pave is underway.

**Mantua Village:** Brush pick-up will be held the second Monday of each month. A new part-time employee is needed at the service garage; contact Anthony Fiorilli if interested. The state recently finished the 2009-2010 audit. Bulk water sales have begun. The Portage County Soap Box Derby will be held on Saturday, June 18.

**Shalersville Township:** The \$50,000 grant received from First Energy has been used to install new doors, windows, and heating controls in the school building. The township has applied for a grant for roadwork. Paving will be done at the Spring Hill Development, at the corner of Peck Road and Route 303. A new truck will be delivered soon.

**Crestwood Schools:** The last day of school was June 9.

**Golf outing:** Joann Vance said the outing was a great success. There were 33 hold sponsors and 14 teams. The event raised \$6,858. After expenses, and paying \$2,000 for this year's scholarships, there is approximately \$1,012 left over in the scholarship fund.
