Meeting was called to order at 7:39 a.m. Introductions were made.

VILLAGE & TOWNSHIP UPDATES

Mantua Township: John Festa reported that a new acting road superintendent has been appointed.

Mantua Village: No report.

Shalersville Township: Dennis Bujak said that repairs are being made at the school. 50 headstones from the 1800's were recently repaired at the cemetery.

Crestwood Schools: Joe Iacono reported that for the second consecutive year, the High School has met 26 standards on which it is evaluated, earning an "excellent" rating. A new student resource officer will be spending 6 hours/day at the Middle and High Schools.

DMRC: Edie Benner said DMRC has been working with the Village to develop a landmark commission, which will allow them to apply for historical grants. Anyone with an interest in historical preservation is welcome to help with this project; meetings will be held four times per year, and they are looking for someone who can do research on historical matters. A logo contest for DMRC is being held

through the end of October. A Village cleanup will be held on October 29, from 8:00 a.m. until noon; students from the High School will be participating, and Chamber members are encouraged to help. Edie motioned for the Chamber to donate \$400 to purchase four Crestwood banners that will be hung in the Village. Tom Kennedy seconded the motion, and it was passed.

CANDIDATES AND ISSUES

David Joyce: David Joyce has recently taken Steve LaTourette's position and is now running for Congress. He talked about the area that he represents and his plans for creating jobs and fighting crime.

Issue 37: Joe Iacano talked about this Crestwood school levy. Money generated by the levy would help replace recent cuts in state funding and help the school avoid making cuts in academic programs and reducing staff.
