Crestwood Local School District News

Crestwood Local School District is in the process of developing a master plan for both instructional programs and support programs. In Ohio, this process for public school planning is known as Continuous Improvement Planning (CIP).

Crestwood's CIP for instruction will include efforts to align what is taught to state educational standards in order to help our students continue their success on state tests such as proficiency tests and achievement tests.

Crestwood's CIP for support programs will include a variety of strategies designed to improve support services such as transportation, food service and maintenance and construction of buildings. One key component of the support CIP is to establish a long-range "master plan" for construction of district facilities based upon the vision of the Board of Education. Project Manager Tom Dean recently prepared a draft of how the district might look in the year 2010. This draft was presented at the September Board of Education meeting and was intended to stimulate input and discussion by employees and members of the communities we serve.
