Village Hosts 300 at New Government Center

On July 9th, 2006, approximately 300 people attended an open house at the new Mantua Village Government Center on West High Street.

Reverend Jeffrey Jackson gave the invocation. In the Mayor's absence, Village Solicitor David Benjamin acted as emcee.

A representative from the office of Congressman Steven LaTourette presented a certificate of Congressional Recognition and Achievement and an American flag. State Representative Kathleen Chandler presented a Proclamation on behalf of the House of Representatives of the 126th General Assembly of Ohio. Portage County Commissioner Maureen Frederick gave the Village a County flag and spoke to the crowd.

Members of Council passed a resolution dedicating the new Government Center to Mayor Claude E. Hopkins for his diligent effort and hard work in making this a successful venture. A plaque was presented to the Mayor's wife, Linda, in his absence.

A proclamation was also presented to Mike McCauley and the Chrysler Corporation for their generous efforts in assisting with the completion of the necessary renovations. Mike generously donated his time and the Chrysler Corporation allowed Mike to work as part of a special community work program.

Also recognized were the Mantua Township trustees for their collaboration in the Village's purchase of the building.

Reverend Douglas Riley did the closing prayer. Those attending were then invited to tour the new facility and to enjoy a lavish array of refreshments.

Hattie Larlham Groundbreaking Kicks Off \$14 Million Campaign

In early September, more than 15 community leaders, Hattie Larlham residents, donors and staff members broke ground at the Hattie Larlham Center for Excellence. Ohio Reps. Kathleen Chandler and Jon Peterson joined 70 other people in attendance to kick off phase one of Hattie Larlham's \$14 million capital campaign called Hope at Work.

Money raised from the project will fund an expansion and renovation of the Hattie Larlham Center for Excellence. It will also aid the advancement of new services, technologies, facility renovations and emergency access upgrades.



"This is an exciting day in our organization's history," said Hattie Larlham CEO Dennis Allen. "Our new Center for Excellence will help us continue to be an innovator in the care for children and adults with disabilities throughout Ohio."

The expansion and renovation, which will be completed in two years, will encompass programs and services designed to assist people with and without disabilities. One such service will be a play center featuring interactive activities that promote the development of cognitive, social, physical and emotional skill levels in children.

Medical and technological improvements will ensure the 126 children and young adults at the Center for Excellence receive the state-of-the-art treatment needed to support their medically fragile conditions.

"It's been 25 years since we last asked the public for help," said Mella Castner, Hattie Larlham director of development. "There are parts of the current building that haven't seen improvements since it was first built in the 1960s."

To date, more than \$8.6 million has been raised during the private portion of Hope at Work. Another \$5.4 million is needed during the public campaign.

Hattie Larlham is a family of agencies dedicated to providing services to children and adults with mental retardation and developmental disabilities (MR/DD). Established in 1961,

Hattie Larlham has expanded from its residential main campus in Mantua, to provide community care through community homes, home and foster care services and an integrated day care. For more information, visit www.hattielarlham.org.

Secretary's Duties:

- Type minutes of meetings, submit to President, and maintain file
- Maintain files of all Chamber documentation
- Assist all committees with correspondence
- Provide summary of minutes to Newsletter Editor no later than 5 days after meetings

Treasurer's Duties

- Under direction of Executive Board, generally supervise the finances of the Chamber, maintaining Chamber accounts

- Distribute membership applications, collect and process membership dues
- Maintain accurate, current lists of Chamber members and contact information
- Approve and pay invoices
- Prepare revenue and expense budgets
